



## MEMBERSHIP APPLICATION

This Membership Agreement is made and entered into this \_\_\_\_ day of \_\_\_\_\_, 20\_\_ by and between Prescott Gun Club, LLC. (hereinafter “Prescott Gun Club”) and \_\_\_\_\_ (hereinafter “Member”). This Membership Agreement will govern the terms of the Member’s membership rights and obligations and is binding contract between the parties. Your initials on each page and signature at the end of this Agreement indicates that you have read the Membership Agreement terms and agree to them, you understand the contents of the Membership Agreement; that you have asked questions about any term of the Membership Agreement that you may not understand and that you are agreeing to be legally bound by all terms and conditions set forth in this Agreement.

1. ASSUMPTION OF RISK AND HOLD HARMLESS: I had read the Assumption of Risk, Indemnity and Liability Waiver Agreement, Range Rules and understand and agree to their terms and conditions.

2. MEMBERSHIP DUES: Membership dues are due and payable in full on 1<sup>st</sup> day of each month during the Membership term, except in the case of any membership commencing at other times of the month, in which case the first month membership amount shall be pro-rated for the first month. The annual administration fee shall be waived for Members in good standing at the one year anniversary date of their membership. Memberships shall continue until revoked by the Member in writing or if the monthly payment is not made for any reason. If the Member’s membership is revoked or his or her monthly payment is not made for any reason, and the Member later desires to rejoin, it will be necessary for the Member to re-enroll, and the Member will be subject to a new administration fee and all new membership terms and conditions then in effect. Members are responsible for updating any credit card, debit card or bank account information changes and Prescott Gun Club is not responsible for termination of the membership due to the change of such information.

3. MEMBER’S RESPONSIBILITIES: Members are fully responsible for the actions of their guests and family members. Members are fully responsible for their personal property and their guest’s personal property and vehicles. In no case will Prescott Gun Club be responsible for theft, loss or the safety of or damage to any Member’s or guest’s property.

4. EYE AND EAR PROTECTION: Eye and ear protection is required at all times by Members and guests while in the range.

5. RIGHT OF REVOCATION: Any Member, guest or person that fails to obey any range officer instructions, range rules, basic firearm safety rules, Prescott Gun Club policies, or any other term of membership is subject to expulsion from the range, suspension or revocation of their membership or range usage rights. There will be no refund of any monies, membership dues or administration fees if any person is required to leave the property or any membership is suspended or revoked as noted herein.

6. RANGE CLOSURE: Prescott Gun Club may from time to time conduct law enforcement, military and other training classes and is required from time to time to maintain the range and its equipment. Accordingly, Prescott Gun Club reserves the right from time to time to close the range to Members as deemed necessary. Prescott Gun Club will make all reasonable effort to minimize range closings and to notify Members prior to closing the range through its website located at [www.prescottgunclub.com](http://www.prescottgunclub.com)

7. PROHIBITED MEMBERS AND RULES: Persons who are forbidden by law from possession of firearms are not permitted to utilize the Prescott Gun Club facilities and will be removed from the premises. By signing this Agreement, you are expressly representing that you are not prohibited by law or any court order from possessing a firearm, you are not under a domestic violence restraining order or injunction and that you are mentally fit to engage in the use of firearms. Individual Members desiring to rent firearms from Prescott Gun Club, without their own firearm may be required to be accompanied by a friend or range officer when shooting. Members shall not be permitted to enter the premises if they are under or appear to be under the influence of alcoholic beverages or drugs. Further, Members affirm they understand the consumption of drugs or alcoholic beverages is expressly prohibited at Prescott Gun Club, and that any person(s) who appear to be under the influence of alcohol, drugs or emotionally unstable, shall be denied access to any part of the premises.

8. DAMAGE TO RANGE PROPERTY: Any intentional or unintentional damage to any Prescott Gun Club property is the Member's sole responsibility to repair or replace at Prescott Gun Club's discretion. Member shall not intentionally shoot at cameras or other range equipment not intended to be shot at. The Member shall report any damage or destruction of any Prescott Gun Club property. Members are fully responsible for the actions of their guests and family members. Member hereby consents to Prescott Gun Club charging its credit card, debit card or bank account for the cost of any repair or replacement to Prescott Gun Club property.

9. LOADED FIREARMS: No loaded firearms are to be left unattended for any reason. No loaded firearms are allowed inside the clubhouse, restrooms, or in any parking area, unless they are secured in a holster and worn on the body in an approved manner. If movement from one range lane to another is required, all firearms must be unloaded, cased or holstered until arrival at the next range lane. All long guns must be cased and unloaded prior to entering the shooting booth. All long guns must be unloaded and cased prior to leaving the shooting booth.
